

May I Help You, Sir? Thoughts on gender perception and identity By Bekah Cardwell

It has happened to me in Safeway, Walmart, Target, Action Power & Equipment and numerous other places that I have visited. "May I help you, sir?" Apparently I confuse people. The most intriguing experiences have been in womyn's bathrooms. Some womyn look at me, then turn around and look at the bathroom door to make sure they are in the right one. I say to them, "Yes, I am a womyn." Their confusion is annoying because they are questioning my intelligence by assuming that they are in the wrong bathroom, which translates that I must be in the wrong bathroom.

My gender is not easily detected by the untrained eye. I suppose I should say that the untrained eye is actually trained by our social restrictions and misgivings. Ever since I was a little girl I wanted to be a boy. I only wanted to be a boy because my upbringing told me that only boys get to marry girls.

I was told that only boys get the best and most fun jobs, like being a professional football player or other such things. I grew up frustrated. I wasn't a boy.

I knew I was gay and I knew that being

a female was a dilemma in our sexist society. As a boy I would not be as objectified and horrified. As a male I would be able to enjoy sex and not have to worry about pregnancy. I realized my intense angst toward my girl self. How could I become a boy?

My Christian upbringing scared me. It told me that what I am is wrong. Being gay was considered despicable, according to my youth retreats and Bible studies. The only alternative was for me to be a boy. But how? I was still a girl no matter what. My birth certificate proved that. In order to be able to fantasize about my inner boyness I created a character. This character was male, the male me. His name was Craig (I'm not sure why). Craig had the greatest clothes, the best hair, and all the girlfriends he could handle. I would shop in Spiegel and JC Penney catalogs for his fictional wardrobe. He made me legitimate. I could at last be a boy. Of course, fantasy can only go so far. I became bored with the inner workings of my mind. I wanted all of those things that Craig had.

I came out to my family when I was 24. My mom was disappointed but her love

has never left me. My siblings didn't seem to care, I will always be their sister and they will always love me. I was thrilled to have such a weight lifted from me. At this time I had long blonde hair; big hair. This big hair helped to hide the real gay me. My friend convinced me to chop it off. "What do you have to hide?" she asked. Exactly — what do I have to hide?

I was nervous. I looked around the salon's floor and saw all of my "blanket" lying there. I was free! My hair was short. I began wearing more masculine type clothes. I shopped in the men's section of department stores. I wore boots, and hats, and Hanes t-shirts, and ugly flannel button-ups. I was my own boy.

I have no real angst when called sir. My angst comes from the disgust that maybe others feel when they believe they have been "tricked." I have found that womvn tend to be more offended when they find out that I am a female. as opposed to men. I feel bad for the men who fall all over themselves to apologize. The females who call me sir or get confused when they see me in the bathroom have been more likely to feel agitated than apologetic. Maybe they had to question gender identity and wonder how many other times they have been confused. Of course, not everyone is bothered by being "tricked."

I'm thrilled with who I am and how I look. It doesn't bother me that people have certain ideas of what things should be like; after all, so do I. At times I am self conscious, but then I smile and remember that I don't have to live in my head anymore. There is nothing wrong with a little confusion here and there.

The Keynote Speaker will be Robert N. Minor, Ph.D., Professor of Religious Studies at the University of Kansas. A native of Milwaukee, Wisconsin, Minor received a Ph.D. in Religion from the University of Iowa in 1975. His current research is on gender studies and the relationships of religion, gender, and sexuality. At the University of Kansas, one of his popular courses is "Religious Perspectives on Selfhood and Sexuality." His most recent book is "Scared Straight: Why It's So Hard to Accept Gay People and Why It's So Hard to Be Human." In 2002 it was named a finalist for both a Lambda literary award and the Independent Publisher Book Award. In little more than a month after its

publication, Menstuff.org, a men's issues web site, named it "Book of the Week." In addition to his keynote speech "New Strategies in LGBT Activism", Minor will be conducting two 75-minute workshops at the conference: "Understanding Homophobia" and "Dealing with Religion When You've Tried Everything and Nothing Seems to Work". On Sunday, September 7, Dr. Minor will be conducting a four hour workshop titled "Personal Growth of Non-Heterosexual People Beyond Coming Out".






Registration information Complete schedules of workshops and other events, along with registration forms, can be found on the Web site at www.pflagwashingtonstate.org.

PFLAG Responds to the Supreme Court's Sodomy Ruling

On June 26, 2003 the United States Supreme Court ruled that Texas' "sodomy" law was unconstitutional, thereby overturning all remaining sodomy laws in the United States. The case was brought by two Texas men who were arrested in one of their homes, held in police custody for more than a day, convicted of moral turpitude and fined. The court was asked to strike down the Texas sodomy law for two reasons — first, that it is an unconstitutional invasion of privacy; and second, that by singling out gay people, it violates the Constitution's guarantee of equal protection under the law.

"The Supreme Court made history today. PFLAG lauds the highest court of the land for striking down state sodomy laws that were discriminatory and unconstitutional. This wide-ranging decision is a landmark in the battle for civil rights and fairness. This ruling will allow our country's GLBT citizens to live their lives and enjoy their relationships without government intrusion, arrest and prosecution.

Moreover, the decision recognizes that such laws fuel anti-gay bias and open the doors of persecution, discrimination and the denial of basic rights such as parental custody, equal opportunity in employment and public service, and basic privacy. This is a great day for lesbian, gay, bi-sexual and transgender people and their families and friends — and for all fair-minded Americans."
